

Next change is TBF has modified the required boat participation in the National Semifinal for advancement slots to the Federation National Championship. The old rule was a state had to field 80 boats to send three teams to the National Championship. The new rule lowers that to 60 boats which is easy for Virginia to achieve. The last change as requested by numerous members is having an optional side pot at State Team Trail Tournaments. Participation in this side pot is optional will be 100% payback spread over the top 3 positions.

We are now at that time of the year when fall patterns start turning on in the woods and on the water for some great hunting and fishing. As we start climbing those trees with the start of bow season in the next couple of weeks be safe. Whether you are fishing or hunting please ensure you are doing it safely. There have been way too many bass boat accidents across the United States this year so please stay alert. Every season we see the stories of hunters falling from trees so put those safety harnesses on so you are ready to fish in the spring. Good luck to all whichever sport you choose this fall.





The Virginia Bass Chapter Federations "TEAM TOURNAMENT TRAIL" series serves as the Virginia TBF National Semi-Final (NSF) Qualifiers plus introduces a new Virginia State Championship Team Tournament. The series consists of 4 qualifying Team Tournaments held in each of 4 Regions (North, South, East, & West) throughout the state. Each qualifying tournament is a single day event. With this format Virginia TBF Anglers now have an opportunity to compete for bigger payouts and a Virginia State Team Championship while reducing their costs plus the benefit of fishing locally on familiar waters. All four regional tournaments are open to all Virginia TBF members in good standing. Teams that fish any of the 4 Regional events qualify for the 2 Day State Championship Team Tournament. The State Championship event has a 100% payback in cash and prizes with a Champions Package awarded to the winning team (cash, awards, apparel, paid TBF National Semi Final entry, etc.).

This is a TEAM TRAIL where anglers complete the registration as a pre-designated team. Launch order is determined by the order in which registrations are received. All Regional Tournaments are single day events. The 2 day State Championship Tournament is only be open to those that fish a qualifying Regional Tournament. Those teams that win a qualifying Regional Tournament will receive free entry into the Championship Tournament. Teams that participate in 2 or more Regional Qualifying Tournaments in a season will have their registration fee reduced for the State Championship Tournament. The winning team from each of the four Regional Tournaments plus the top six teams (6 Anglers & 6 Co-Anglers) from the State Championship Team Tournament will make the **Virginia State Team**.

**NEW For 2025 – Virginia Angler & Co-Angler of the Year:** Anglers will receive points for each Team Trail event they fish each season. The Angler and Co-Angler accumulating the most points from their best 4 out of 5 Team Trail Tournaments will be awarded the **Virginia Angler of the Year** and **Virginia Co-Angler of the Year.** Virginia's Angler and Co-Angler of the Year may bypass the National Semi Final event and advance directly into the TBF National Championship Tournament.

Teams have 3 options available for registration for the 4 Regional qualifying events.

- 1. Teams can download from the State Web Site (<a href="www.vabass.com">www.vabass.com</a> ), print, complete the registration, and mail the completed form with a check for payment. This method MUST be postmarked no later than 10 days prior to the event.
- 2. Teams also have the option to complete the registration and pay online through a link available on the State Web site (<a href="www.vabass.com">www.vabass.com</a>). The online registration cutoff is midnight the Wednesday prior to the tournament.
- 3. If Teams do not register in time they may register at the tournament site the morning of the event. There will, however, be a \$25 administrative fee added to the tournament registration fee.

Registrations for the Virginia State Championship Team Tournament will be open by invitation to all qualifying teams.

Each year Federation anglers from throughout the nation compete through their respective club and State Federation Tournament Trails for the opportunity to advance to the TBF National Championship Tournament. The TBF's National Semi-Final Tournaments are the final qualifying events for the Federation National Championship. The National Semi-Finals format is comprised of 21 close to home district competitions with the top anglers and co-anglers from each state advancing to the "No-Entry-Fee" TBF National Championships.

Kerr Lake's North Bend State Park was the site of the 2024 TBF District 12 National Semi Final Tournament hosted by the Virginia Bass Chapter Federation on September 21<sup>st</sup> and 22<sup>nd</sup>. This two day Federation National Championship qualifying event featured the top anglers from both Virginia and West Virginia. Fifty-eight teams competed in this season's semi final tournament for their share of a \$19K plus payout and the opportunity to represent their State Federation at the Federation National Championship Tournament next spring.





Following three days of official practice, the weekend's activities started with angler check in and a pretournament meeting on Friday evening at the Southside Rescue Squad facility in South Hill, Virginia. The tournament staff went over the tournament rules, show times and issued the tournaments partner pairings for Day 1 of the two day competition along with the tournament launch order. Anglers also enjoyed some fellowship and drawings for a myriad of door prizes including sponsor product, fishing rods, tackle items, and a Lowrance HDS 7 Ti depth finder.



**DAY 1:** On Saturday morning the competitors began arriving at Kerr Lake's North Bend Park Special Events Area starting around 5:00 AM in preparation for a "safe-light" tournament blast off. Temperatures were in the mid sixties at the start of day one of this championship tournament and warmed to around 80 degrees by the time the first flight of anglers began returning for their 3:30 PM weigh-in.


In the Angler Division: Virginia anglers topped the leader board on this first day. Star City Bassmasters angler Clay Ross brought five bass to the scales weighing in at 15.11 pounds for the top spot. Following in second place was Frank Harris from the RVA Bassmasters with a limit of bass weighing 13.38 pounds. NASA-Langley Bassmasters angler James Whitehead's limit of bass weighed in at 13.24 pounds for the third spot. James Vick from the Tri-City Bassmasters followed in fourth place with his 12.26 pound limit of bass. The top West Virginia angler on day one, Andrew Goins, held fifth place with his limit of bass that weighed in at 10.96 pounds. Another West Virginia angler, Wes Lester, followed closely with five bass weighing 10.77 pounds for the sixth position. In seventh place was Virginia's Mount Vernon Bass Masters angler, Kenny Brown with

10.23 pounds. The eighth place angler, Jeff Meade, from the Battlefield Anglers of Virginia, had a limit of bass weighing 9.90 pounds. In ninth place, angler Rick Mills from Virginia' Hook'em Bass Anglers also weighed a limit of bass for 9.81 pounds. Virginia angler Dave McLean from the Peninsula Bass Anglers weighed in 9.54 pound of bass for the tenth spot.

In the Co-Angler Division: West Virginia anglers held the top two places the first day. Bill Harmon led the field with five bass weighing in at 8.11 pounds. The second place co-angler was Laythen Good with four bass weighing 7.51 pounds. Larry Whitt, from Virginia's Nottoway Bassmasters, held on to the third place with four bass weighing 6.82 pounds. Another Virginia co-angler Tracy Gravely from the RVA Bassmasters weighed in three bass at 6.31 pounds for the fourth spot. Star City Bassmasters co-angler Brian Epperly Jr. had four bass that weighed 6.10 pounds for fifth place. The sixth place co-angler on this first day of competition from the 5-Rivers Bassmasters with 6.02 pounds was Mark Elliott. In seventh place was Clyde Cheek from the Tri-City Bass Masters brought three fish to the scales weighing 5.85 pounds. West Virginia's Robert Harkness held the eighth spot with four bass weighing in at 5.76 pounds. Virginia co-angler Danny Sage from the Southside Bassmasters managed a limit of bass weighing 5.52 pounds for ninth place. The tenth place co-angler was West Virginia's Timothy Isaacs with three bass weighing 5.26 pounds.

The Big Bass on Day 1, a 5.01 pound largemouth, was caught by Virginia's Co-Angler Blake Meeks.

Day one proved difficult for most of the field as only seventeen of the one hundred sixteen competing anglers brought a five fish limit of bass to the scales. Anglers reported that the top water bite was good early then the fishing got tough as the day progressed.



**DAY 2:** The morning temperatures on Sunday were in the lower sixties with overcast skies with a dense fog that had settled over the lake overnight. The start of the final day of the championship tournament was delayed for about an hour waiting for the fog to lift enough for a safe launch.









DAY 2 - Angler Division: First day leader, Clay Ross added to his lead with his Day 2 limit of five bass weighing in at 13.99 pounds securing the tournament win with a total weight of 29.10 pounds. Virginia's James Whitehead move into second place in the standings with a five bass limit weighing in at 11.80 pounds. James anchored his day 2 limit with a 5.03 pound largemouth bringing his total tournament weight to 25.04 pounds. Frank Harris secured a third place finish with a Day 2 limit weighing in at 10.31 pounds. Franks total for the tournament was 23.69 pounds. West Virginia angler Andrew Goins finished in fourth place with a Day 2 weight of 9.54 pounds, his total tournament weight was 20.50 pounds. Virginias Nottoway Bassmasters angler Donnie Gregg moved from the eleventh spot on Day 1 to finish in fifth place with a limit of bass weighing 10.47 pounds. Donnie's total tournament weight was 19.09 pounds. Jeff Meade from the Battlefield Bass Anglers of Virginia weighed in an 8.56 pound limit on Day 2 moving his total tournament weight to 18.46 pounds for a sixth place finish. Kenneth Brown held on to seventh place with four bass on Day 2 that weighed 8.08 pounds. Kenneth's total weight for the tournament was 18.31 pounds. Dave McLean moved into the eighth position with his Day 2 weight of 8.51 pounds. Dave finished the tournament with a total weight of 18.05 pounds. Virginia's Chris Fiore from the RVA Bassmasters moved from fourteenth place on Day 1 to finish in ninth place with his Day 2 limit of bass weighing 9.91 pounds. Chris finished the tournament with 17.85 pounds. West Virginia's Mike Goff made the biggest move up the standings in the Angler Division on Day 2 moving all the way from 32<sup>nd</sup> place on Day 1 to finish in tenth place with his Day 2 limit of bass weighing in at 12.97 pounds. Mike finished the tournament with a total weight of 17.73 pounds.







DAY 2 – Co-Angler Division: Day 1 leading co-angler Bill Harmon from West Virginia weighed in a 6.65 pound limit of bass on Day 2 bringing his total tournament weight to 14.76 pounds to secure the win in the tournaments Co-Angler Division. Virginia's Larry Whitt moved into second place with a five bass limit weighing 7.70 pounds. Larry's total tournament weight increased to 14.52 pounds. Virginia co-angler Drew Nalls from the Bass Snipers weighed a 7.97 pound limit of bass to bring his total weight to 13.18 pounds securing third place. Joe Bandish from the Battlefield Anglers of Virginia posted the best co-angler weight of Day 2 with his 9.89 pound limit of bass. Joe moved from  $27^{th}$  place on Day 1 into the fourth place with a total tournament weight of 12.86 pounds. West Virginia's Laythen Good weighed four bass on Day 2 adding 5.22 pounds which brought his total tournament weight to 12.73 pounds to finish in fifth place. Virginia co-angler Blake Meeks from the Blackwater River Bass Club brought two bass to the scales that weighed 5.60 pounds. Blake finished in sixth place with a total weight of 10.61 pounds. William Posey from West Virginia weighed a 9.41 pound limit of bass launching him from 44<sup>th</sup> place in the Co-Angler Division on Day 1 into seventh place with a total tournament weight of 10.47 pound. Tri-City Bassmasters co-angler Clyde Cheek had three bass on Day 2 that weighed in at 4.57 pounds securing him an eighth place finish with a total of 10.42 pounds. Mike Guzik from the Nottoway Bassmasters weighed in four bass on Day 2 bringing his total weight to 10.40 pounds to finish in ninth place. The tenth place co-angler was West Virginia's Robert Harkness with his total tournament weight of 9.56 pounds.

West Virginia's **Bill Mossor** weighed the Over-All Big Bass for the tournament, a 5.20 pound largemouth.

The TBF National Championship is a no-entry-fee tournament for the Top Anglers advancing through this Divisional National Semi Final Tournament. The TBF Championship is a weeklong event with the location announced later this year. In addition to the cash prizes, all anglers will receive a TBF National Championship hotel room stipend from TBF for the actual event days as a part of their qualifying prize. Additionally, all Boaters will receive a cash fuel stipend to help offset their boat costs. All 14 finalists can earn a Living YOUR Dream prize package of various sizes, and can advance to the 2024 BFL All-American if they are qualified. Anglers compete for one of two championships: the Angler (boater) Champion or the Co-Angler Champion. Following the official practice days, the full field competes on Days 1 and 2, and then the field is cut to the champion of each TBF's 7 geographical divisions. These Division Champions compete on the final day for the TBF "Live YOUR Dream" prize packages. At the 2024 Championship tournament, the boater National Champion's "Living Your Dream" package was valued in excess of a whopping \$125,000 in cash and prizes including a brand-new Ranger Z520 powered by Mercury 250HP outboard engine, rigged out and to KEEP! PLUS, a \$20,000 CASH prize, paid entry fee stipend into whatever they want to fish and much more! The Federation strongly believes in the value of co-anglers, so the 2024 National Champion Co-Angler "Live YOUR Dream" package was worth over \$30,000, including \$20K cash PLUS set paid entry stipends into the circuit of choice, and more!





# Virginia Angler & Co-Angler Of the Year Virginia Chapter Feberation Chapter Feberation

The Virginia Angler of the Year and Co-Angler of the Year is a NEW Angler Recognition Award that acknowledges the Angler and Co-Angler with the best overall performance each season and gives them the opportunity to advance directly into the TBF National Championship Tournament, bypassing the National Semi-Final qualifying tournament.

Beginning with the first Team Trail Tournament of the 2025 Season, the North Regional on the Potomac River, anglers will now be awarded points for each Team Tournament Trail tournament that they participate in. At the end of each season the Angler of the Year and the Co-Angler of the Year will be awarded based upon the total points earned for their best 4 out of 5 Team Trail tournaments. The Virginia Angler of the Year and Co-Angler of the Year may bypass the National Semi-Final Tournament to advance directly into the TBF National Championship.

Here's how the points will be awarded: The system is a 200 point system with a +2 points for the tournament winners. The top points awarded will be 200 for the winning anglers (200 for the Angler and 200 for the Co-Angler). 2<sup>nd</sup> place anglers will receive 198 points, 3<sup>rd</sup> place anglers will receive 197 points, 4<sup>th</sup> place – 196 points, etc. Any anglers participating and not weighing fish will receive 50 points each. Each Angler and each Co-Angler points from their best 4 out of the 5 team Trail tournaments will be totaled and counted towards the Angler of the Year or Co-Angler of the Year Award.

The Angler of the Year and the Co-Angler of the Year will qualify to advance to the TBF National Championship and receive a prize package as determined by the State Board of Directors. To maintain their entry into the TBF National Championship Tournament both the winning Angler of the Year and the Co-Angler of the Year must commit to participate in the TBF National Championship event by December 1<sup>st</sup> each year. No substitute anglers are allowed. Therefore, if either the Angler of the Year or the Co-Angler of the Year declines to participate then neither angler can advance to the National Championship event. Once both anglers have committed to participate in the TBF National Championship Tournament, the State Federation will make the necessary arrangements with TBF, Inc. to secure their berth in the Championship event as Virginia's Angler and Co-Angler of the Year.

With the NEW Angler & Co-Angler of the Year Award, each Team Trail participant can now compete for the opportunity to advance directly into the No-Entry-Fee TBF National Championship event as the Virginia Angler of the Year or Co-Angler of the Year.

The Virginia Bass Chapter Federation Team Tournament Trail format stays the same as in past years – 4 Regional Tournaments and a Team Trail State Championship Tournament.



A note from the VP:

### **New System for Life Jacket Labeling**

The traditional life jacket "Type Labels" we have all grown accustomed to are transitioning to a new internationally recognized system and are now starting to appear on the market. The new labeling system will rely more on "icons" and less on wording. Fortunately, your current life jackets labeled by "Type" can remain in use as long as they are in serviceable condition.

Since 2014, the US Coast Guard has been moving towards adoption of a labeling system consistent with international labeling. The new labeling system relies on a series of icons to identify the devices performance level. The Type I through V labeling is being replaced with a system that will identify life jackets as either "wearable" or "throwable". "Wearable's" are divided into 5 buoyancy categories: 50, 70, 100, 150, and 275 Newtons.

OK..... so what's a Newton? Here's a quick explanation: Liquid exerts a force on objects immersed or floating in it. This force is equal to the weight of the liquid that is displaced by an object. The unit for the **buoyant** force is the **Newton** (N). One Newton = 0.2248089438709618 pounds. For example: "70"represent approximately 15.5 lbs of buoyancy. The average person requires between 7 to 12 lbs of buoyancy to keep afloat with their head above the water.

The term "Life Jacket" will be used to indicate those wearable devices that, in most cases, are designed to turn the wearer face up so the victims head is out of the water. Those wearable devices that do not turn the victim face-up are considered a Personal Flotation Device or PFD (they serve as a flotation aid). The current Type IV "throwable" is also a PFD as it is only intended to serve as a flotation aid. It is a "throwable PFD". To reference to the current US labeling, only the Type I and possibly a few Type II devices will be considered "Life Jackets" as they turn the wearer face up. Other Type II and Type III devices serve as PFD's (they will not turn you face up).

With the new labeling system, a series of "Icons" are provided to indicate the activities the PFD is *not* approved for, thus eliminating the old "intended use" designations. Icons are also used to identify the performance rating. The lower the buoyancy numbers the greater the mobility and comfort. The higher the buoyancy number, the greater flotation, ability to turn, and stability in the water (for example: a 100 *may* and a 150 *should* turn the wearer face up where a 275 is specifically designed to turn the wearer face up). Some examples of the buoyancy ratings and potential use:

Level 50 - for paddle board use or use close to shore where help is likely to happen quickly.

Level 70 - for inflatables, active wear, with help nearby.

Level 100 - provides more performance than the Level 70, better buoyancy.

Level 150 - off shore use where help is not likely for some time. This device will keep you face up.

Level 275 - off shore or heavier duty for commercial and industrial use.

The use of the curved-arrow icons will indicate how effective the life jacket will turn a person face up or not.


Like with the current labeling system, the new labels will also indicate whether the device is for use by Adults, Youth, Toddler, or Infants. As we do now, consider the labeled weight and chest measurements for your best fit. The buoyancy level will be an individual's choice based upon intended use or environment.

Note from the VP continued:

New devices will include a "hang tag" that will explain the new labeling and help when choosing the correct device.







### **Understand the use and certification labeling:**

**Size panel:** The size panel lists, in US/Imperial and Metric units, the approved body weight and chest sizes (where applicable) for the particular PFD.

Warning panel: The warning panel contains the "not approved for" icons and other safety information.

**Maintenance panel:** The Maintenance panel covers such things as inspecting the PFD before each outing, storing in a cool place out of sunlight and drying before storage.

**Certification panel:** The certification panel indicates that the device is certified by an acceptable third-party organization and is approved by the U.S. Coast Guard and Transport Canada. It also lists the manufacturer's name, contact info, device lot and model number.

### **Conservation Director** John Flicek

Invasive species continue to be a hot topic of real concern. We've been working the past few years in cooperation with VA DWR fisheries to do what we can to help curb the spread of Alabama Bass that have been illegally introduced into Virginia waterways through a campaign centered upon education and reporting.

During the recent TBF National Semi-Final Tournament on Kerr Lake we have experienced just how aggressively Alabama Bass have spread throughout the lake. In March 2021 we reported the first confirmed catch of an Alabama Spotted Bass in Kerr Lake and continued to see a few spotted bass in our tournaments in 2021 through 2023. At the time surveys indicated that they were primarily found in the Eastland Creek and North Bend areas of the over 50,000 acre reservoir. Now in 2024, tournament anglers are finding spotted bass throughout the lake. This year we are seeing that a larger percentage of the bass brought to tournament scales being spotted bass. During the 2 Day National Semi-Final Tournament in September 2024, we estimated that 65% to 70% of the bass weighed were spotted bass. The rapid spread of Alabama Bass isn't a good trend. While we are seeing some sizable (3 to 4 pounds) Alabama Bass now, the long range outlook could result in large numbers of smaller fish as they overpopulate and outcompete native largemouth bass. Unfortunately, as the result of the illegal introduction of Alabama Bass, we will likely see a continuing decline in the Kerr Lake largemouth bass population. Kerr Lake along with its downstream neighboring Lake Gaston, are prime examples of how quickly the introduction of nonnative species like the Alabama Bass can irreversibly impact a fishery.

I've completed what I hope will be the final upgrade to the Release Pipe at the Chickahominy Riverfront Park tournament weigh-in site. The modifications the past summer included the installation of a 1 ½ inch water line from the base of the pipe to the top, the installation of a shut-off valve and faucet to enable a hose connection to fill tournament weigh-in tanks. These upgrades eliminate the need to drag hoses from Gordon's creek to the head of the pipe during use and to fill our weigh-in tanks while allowing for connection of a higher volume pump. Connections are now available at the base of the pipe for either a 1 ½ inch feed or a garden hose line from your submersible pump. Users can direct the water flow using the valves installed at the base of the pipe. Users of the release pipe are reminded that they MUST maintain a continuous flow of water down the pipe while in use. The more water flow the better for the fish - we recommend a higher volume pump. Failure to maintain a good flow will harm the fish and park personnel will deny use without water flow. Users may contact me if there are questions on how to adapt their current pump setup to the upgraded pipe.

### **Invasive Species Efforts ---** What do you need to know?

"CLEAN – DRAIN – DRY": Anglers are reminded that the unauthorized movement of fish/plants/aquatic life from one body of water to another jeopardizes the health of our fisheries and is illegal. Aside from the illegal movement of fish other measures have been enacted to help curb the spread of invasive species and nuisance plants/organisms with the implementation of "CLEAN – DRAIN – DRY" policies. Boaters are now required by law to remove any vegetation from their boat/trailer and drain bilges when removing there vessel from the water. The regulation doesn't require that you immediately drain livewells if you are retaining your catch for weigh-in or harvest. However, unused livewells and baitwells should be drained on site. Regulations also require that reasonable measures should be taken to dry out bilges, livewells and baitwells prior to launching into another body of water.

**ALABAMA BASS:** The Alabama Bass Education, Identification, and Containment Project efforts continue with distributing the educational brochures and sampling packets throughout the State. Anglers are asked to report all suspected Alabama Bass catches from any body of water other than the Claytor Lake, Diascunds Reservoir, Kerr Lake, and Lake Gaston. The VA DWR Fisheries Management Team has put together a rapid response group that will investigate reported catches in an attempt to measure the extent of the Alabama Bass movement and make recommendations for future actions necessary to contain their spread. Anglers are encouraged to harvest all spotted bass caught.

Anglers are reminded that it is Illegal to stock fish into a public body of water without an authorization from Virginia Department of Wildlife Resources (DWR). Anyone with knowledge of intentional stockings of Alabama Bass or Spotted Bass should contact DWR law enforcement at 800-237-5712 or WildCrime@dwr.virginia.gov.

The Reporting Process - If you catch a suspected Alabama Bass:


- 1. Take a picture of the fish.
- 2. Clip off a thumbnail-sized portion of one of the pelvic fins (pelvic fins are located on the bottom of the fish, just under the head.)
- 3. Store the fin clip dry in an envelope.
- 4. Email picture to: <a href="mailto:fisheries@dwr.virginia.gov">fisheries@dwr.virginia.gov</a> for verification with name of angler, location caught, date caught, & phone number.
- 5. Mail the fin sample collected to the address provided when requested.

**NORTHERN SNAKEHEADS:** Anglers are reminded that it is illegal to possess a live snakehead in Virginia. Anglers are encouraged to kill and report any snakeheads they encounter. In an effort to track Snakehead migration VA DWR has established a **SNAKEHEAD HOTLINE** that anglers can use to report snakehead fish: **(804-367-2925)** report the angler's last name, date of catch, location of catch, and size.

Anglers are required to report snakeheads if caught. Snakeheads <u>must be dead if in possession</u> (contained in live well, cooler, etc.). The DWR asks that all snakeheads be killed if possible. If an angler wishes to keep a legally caught northern snakehead, the fish must be killed to be in possession.



### Greeting TBF Members,

In July I had the privilege of attending the ICAST trade show in Orlando, Florida on behalf of the United States Fish and Wildlife Service (USFWS). ICAST is the fishing industry's big trade show and is where manufacturers showcase new products. I know you've all read the articles covering new innovations in tackle and boats and if you're like me, you've bought many of these products immediately after they become available.

There were two reasons I attended ICAST, and I think they are both interesting items for TBF members living in Virginia. The first was to work with the USFWS as they talked to manufacturers about the Sport Fish Restoration Program and the excise taxes placed on sport fishing equipment. If you weren't aware, most fishing tackle has an excise tax that is paid by the manufacturer to the federal government. These funds are then distributed to the states based on a formula based on the area of the state as well as the number of fishing licenses sold by that state. These funds are critical to funding fisheries management, fish stocking, and boating access across the country and compliments fishing license revenue. If you've ever seen the Sport Fish Restoration signs at a boat ramp, that's where the funding came from. And to clarify a point that regularly comes up – Virginia DWR is not a general fund agency – the general fund does not fund the work we do. Its license revenue and Sport Fish Restoration money. Buying tackle directly funds quality fishing. So go ahead and get that extra glide bait.

The second reason was to speak with Virginia based manufacturers of tackle and outdoor equipment. One of the points that I make to people who don't fish is that fishing is important to Virginia's economy – the American Sport fishing Association estimates that freshwater fishing supports more than 4,000 jobs and nearly \$600 million in economic impact in the Commonwealth. There were seven companies from Virginia at the show and I bet that you have some of their gear in your boat. Missile Baits out of Salem makes a lot of soft plastics and jigs. Rapid Fishing Products out of Mechanicsville makes a lot of fishing "solutions" – terminal tackle, keepers, etc. Yak Attack out of Farmville manufactures kayak fishing focused gear. These and the other larger companies compliment the smaller manufacturers that we have in Virginia. So, keep an eye out for "Virginia grown tackle".

Another cool part of the show was getting to meet a lot of the legends of the fishing world. My top moment was running into Hank Parker and talking with him for a few minutes. Like a lot of you, I grew up watching him on TV. If you are wondering if he is as nice in person as you would expect, he is even nicer than that!

Good luck fishing this fall.





### DO YOU KNOW THE DIFFERENCE?





- Anglers are reminded that the introduction of novel predators can have unforeseen impacts on native or established ecosystems.
- The introduction of Alabama bass is illegal in Virginia. Alabama bass have been scientifically shown to out-compete established populations of largemouth bass and hybridize with smallmouth bass.
- Invasive species cause negative ecological and/or economic harm.
- Anglers who suspect they have captured an Alabama bass should take a picture of the fish, clip
  off a thumbnail-sized portion of one of the pelvic fins, and store the fin clip dry in an envelope.
  The pelvic fins are located on the bottom of the fish, just under the head. They should then either
  contact the Department of Wildlife Resources at: fisheries@dwr.virginia.gov or 804-367-1293.





# James City County Tournament Facilities

James City County Parks and Recreation welcomes local, regional, and national fishing tournaments at Chickahominy Riverfront Park and Little Creek Reservoir Park. A **Fishing Tournament Permit** is required for any tournament of 20 boats or larger. Chickahominy Riverfront Park (CRP) can accommodate larger tournaments of up to 100 boats. Little Creek Reservoir Park can accommodate smaller tournaments. Unfortunately, fishing tournaments are not allowed to launch from Brickyard Landing Park.

Optional amenities at CRP include a dedicated tournament weigh-in area, field/fishing pier rental (exclusive), and the option to conduct weigh-in activity in the boat trailer parking area (limited to a 72"x30" table or truck bed for weigh-in).

The unique amenity at CRP is the dedicated Tournament Weigh-In Site. The site can be rented for \$30/day and includes power access at the old camping site #111. The site must be rented in order to have access to the fish release pipe. To use the pipe, you must pump water to the head of the pipe from Gordon's Creek and maintain sufficient water flow during fish release (user must supply their own submersible pump). Additional instructions are posted on site.





### **James City County Fishing Tournament Permit Process**

- 1. A permit is required for ALL Tournaments of 20 Boats or more. The Permit Application is completed through the JCC PermitLink System <a href="https://jamescitycountyva-energovweb.tylerhost.net/apps/selfservice#/home">https://jamescitycountyva-energovweb.tylerhost.net/apps/selfservice#/home</a>
- 2. There is a \$25 permit processing fee (it is recommended that if you are having multiple tournaments during the year at the same location that you put all the dates on a single application).
- 3. There is a \$250 refundable security deposit required when processing the permit(s).
- 4. A Certificate of Insurance showing \$1M liability coverage with James City County shown as the additional insured is required for each event at least 30 days prior to the tournament.
- 5. Prior to the tournament the JCC Facility Coordinator (permit office) will email the Tournament Organizer a James City County Dated Ramp Pass that you can reproduce as needed for your tournament.
- 6. Tournament Organizer is REQUIRED to collect ALL ramp fees for your participants and make payment at the park office by noon of the tournament day (\$8 Non-James City County residents, \$5 for county residents, waived for annual pass holders and campers).
- 7. The Tournament Organizer is required to check-in with the Park Coordinator or Guest Services no later than 30 days prior to the event.
- 8. The County will issue permits for multiple tournaments or park activities on any given day up to the limit of available parking. Tournament Organizers are encouraged to coordinate launch and weigh-in times/locations for their tournaments to minimize congestion during launch and recovery at the ramp area.
- 9. No parking is allowed at any time on the roadway in front of the weigh-in site. All vehicles and trailers must be parked in the designated parking area in the field. If the weigh-in site is rented, it is the responsibility of the tournament director to manage its access, use, and cleanup.

# Virginia Anglers Compete on Lake Hartwell







# Virginia Junior Anglers Compete on Lake Hartwell



The Virginia Junior Angler State Champions Wyatt Reynolds and Hampton Hancock-Ward from the Ridgefield Junior Anglers competed on Lake Hartwell in Anderson, SC in the TBF Junior Angler World Championship Tournament along with 71 Junior Teams from across the US and Canada, on 24-26 July.

The Junior World Championship is a 3-Day event with the field cut to 15 Teams after Day-2. Under the new format, the Championship Round Qualifiers include the 5 Division Champions plus the addition of 4 teams from the two largest Divisions, the 5 teams with the next heaviest weights from days 1 and 2 and a "lucky dog" qualifier drawn from the field. All 15 teams making it to the Final day each won a scholarship with the total payout of \$15,000.00 dollars in scholarships for this year's Junior World Championship anglers.

Wyatt and Hampton weighed a three fish limit each day of the qualifying round. Their 5 pounds 11 ounces on Day 1 and 6 pounds 5 ounces on day 2 landed them in 14<sup>th</sup> Place with 12 pounds total going into the cut for final days Championship round. Advancing to the Championship Round on Day 3, the boys managed another 3 fish limit weighing in at 3 pounds 13 ounces to finish in 12<sup>th</sup> Place.

# Virginia Youth Anglers Compete at State Federation Region Tournaments

Under the new format for Virginia Youth Anglers, teams are allowed to participate in State Federation Region Tournaments and earn points towards a State Youth Team of the Year Title. Youth Teams enter (no entry fee), launch, and weigh-in with the adults during Region Tournaments. Teams are awarded points based upon the number of Youth teams competing in the event and their finishing place among youth teams. Points for the youth teams from throughout the state will be complied and their top 3 point earning events will be tallied to determine the Virginia Youth Team of the Year. Each year the Youth teams from throughout the state will gather for a tournament and head to head competition to determine who will represent Virginia at the TBF Junior World Championship Tournament.

Virginia High School Angling Teams are also invited to compete at State Federation Region Tournaments to earn points towards a Virginia High School Team of the Year title. The High School Anglers also compete in the Student Angler Federation events and the SAF hosted State High School Championship Tournament each year.

Youth Anglers must be a member of an active TBF Junior Club or the Student Angler Federation (SAF). Each Youth Angler Team must arrange for their own boat and boat captain and complete the required Emergency Medical Information Event and Liability/Parental Consent forms. Youth Teams will launch and weigh-in with the host tournament anglers and earn valuable points towards the Virginia TBF Junior Angler or High School State Championship title.







As usual we will ask each participant to donate at least 2 new baits or tackle items to our donation bin to participate in this event. There will be plenty of food and door prizes for all. Hopefully I'll have the end of season awards in hand to present.

I'd like to take a moment to thank everyone that helped with the Lynn Hoeffer Benefit Open Tournament this past July 27<sup>th</sup>. Lynn Hoeffer, a longtime member and avid bass angler who competed in several local clubs and tournament trails, is battling the effects of a hemorrhagic stroke he suffered in December. The TBF National Semi Final (NSF) Tournament was on Kerr Lake, September  $21^{st}$  &  $22^{nd}$ . Region 8 had 36 anglers compete this year with some great results on what proved a difficult few days of fishing. NASA-Langley Bassmasters James Whitehead finished in  $2^{nd}$  Place in the Angler Division and Nottoway Bassmaster angler Larry Whitt finished  $2^{nd}$  in the Co-Angler Division. Their second place finishes earned each of them a berth in the 2025 No-Entry-Fee TBF National Championship Tournament next spring. It was a difficult couple of days as the fish were not very cooperative. In the Co-Angle Division: Larry Whitt –  $2^{nd}$  Place, Mike Guzik –  $9^{th}$  Place, and Tracy Gravely –  $11^{th}$  Place). Great Effort Everyone!

The Region 8 Board of Directors has been busy working on plans for next season. As you will see in this edition of Tightlines we have finalized and released the 2025 tournament schedule. The 2025 will again have 8 tournaments and we will count the best 6 out of 8 towards the season championship. We also will be experiencing some new waters next season – Lake Chesdin & the Chowan River.

We've also approved some payout enhancement starting in 2025. **NEW FOR THE 2025 SEASON:** Starting with the 2025 season we will be implementing a Region 8 Champions prize fund that will be awarded to our 1<sup>st</sup> and 2<sup>nd</sup> Place Season Champions. We also will be adding another \$400 to the 2025 Member Appreciation Tournament payout. We will be keeping the "Side Pot" at each of our regular season tournaments. This "side pot" is completely voluntary for participation. The "Side Pot" fee is \$20 per boat and will only be collected at team check-in for each tournament. Payout is a 100% cash payment to the top boats that chose to participate for that tournament.

Also: The State Federation has made a few changes for 2025: The State Federation is introducing the Angler and Co-Angler of the Year recognition to the anglers that have the highest total points awarded for participation in the best 4 out of 5 State Team Trail Tournaments each season. The 2025 Angler & Co-Angler points awards will start with the Team Trail North Regional on the Potomac River, October 26<sup>th</sup>, since it is the first tournament of the 2025 Team Trail season. The State Federation will also be offering a voluntary "Side Pot" at all State Team Trail tournaments in 2025.




